## Personal data

### **Data relating to members**

The personal data provided by artists or beneficiaries within the framework of their membership shall be processed by the ADAGP solely for the purposes of the fulfilment of its legal and statutory assignments.

This data shall be intended exclusively for the staff of the ADAGP, collective management organisations based within and outside the European Union with which the ADAGP has signed a representation agreement (sister companies) and individuals in possession of access rights according to the legal provisions in force.

For the purposes of managing said rights, the ADAGP shall publish a list of the authors in its directory from its Website, i.e. the full names of the authors (or if applicable their pseudonym), their dates of birth and death and the type of rights managed by the ADAGP.

Subject to the legal obligations, particularly in relation to tax, which state that certain information must be retained for a longer period, the data collected by the ADAGP shall be retained for the duration of the membership, which may be extended if applicable in accordance with Article 6 and 48 of the Articles of Association, until the expiry of the current operating authorisations.

### **Data listed in the distribution lists**

The personal data which is collected within the framework of registration with the distribution lists of the ADAGP shall be used solely to enable the ADAGP to send information letters relating to its activities. It is possible to unsubscribe at any time.

This data is intended exclusively for use by the ADAGP services. It shall be retained for the term of registration with the distribution list.

### **Data linked to the use of the site**

Data is temporarily stored in cookies to allow for optimum browsing activities on the site, particularly relating to the consultation of the image bank.

Cookies are also used for statistical purposes to determine the number of visits, the number of pages consulted, the activity of site visitors and the frequency with which they return.

This data is intended exclusively for use by the ADAGP services. It shall be retained for a maximum period of 13 months.

### **Access rights**
